Ordinance 19

AN ORDINANCE PROVIDING FOR PUBLICATION
OF BIDS BY THE EUREKA FIRE PROTECTION DISTRICT
OF ST. LOUIS COUNTY, MISSOURI

WHEREAS, the Eureka Fire Protection District of St. Louis County, Missouri, encompasses areas within St. Louis County and Jefferson County, Missouri; and,

WHEREAS, the Eureka Fire Protection District of St. Louis County, Missouri, was incorporated pursuant to vote of the citizens of the County of St. Louis, Missouri, and approved by order of the St. Louis County Circuit Court; and,

WHEREAS, St. Louis County, Missouri, is a first class home rule chartered county of the State of Missouri; and,

WHEREAS, Section 321.600, et. seq., Revised Statutes of Missouri, 1978, as amended, provides in part that fire protection districts in Missouri in first class home rule chartered counties must let for bids for materials and services in the amount of \$5,000.00 or more;

NOW THEREFORE, be it ORDAINED by the Board of Directors of the Eureka Fire Protection District of St. Louis County, Missouri, that:


ORDINANCE NO. 19

AN ORDINANCE PROVIDING FOR PUBLICATION OF NOTICE OF BIDS FOR A PERIOD OF TWO (2) CONSECUTIVE WEEKS WITH PUBLICATION TO BE ONCE PER WEEK IN A NEWSPAPER OF GENERAL CIRCULATION IN THE COUNTY OF ST. LOUIS, MISSOURI, WHICH DAY OF PUBLICATION NEED NOT BE ON THE SAME DAY AND WHICH PUBLICATION SHALL BE COMPLETED AS OF THE DAY OF LAST PUBLICATION.


SECTION 1. Notice of Advertisement for Bids of the Eureka Fire Protection District of St. Louis County, Missouri, shall be made once a week for two (2) consecutive weeks in at least one newspaper of general circulation in St. Louis County, Missouri, the county in which the District is incorporated and a substantial portion of the District is located.

SECTION 2. It shall not be necessary that publication be made on the same day of the week in each of the two (2) weeks and that publication shall be completed on the day of the last publication.

This Ordinance No. 19 having been duly considered and voted upon by the Board of Directors of the Eureka Fire Protection District of St. Louis County, Missouri, was enacted as an Ordinance of said District on the 6th day of June, 1985, and shall become effective as provided by law.
